




DISABILITY DAY CARE NEWSLETTER Summer Edition 20.05.22

- The Southern Health & Social Care Trust [SHSCT] has developed a Disability Day care rebuild plan with 10% weekly targets to increase day care places based on a risk assessment framework, the progress can be seen on the table below from 28.03.22 until 18.05.22
- In addition transport services have also increased capacity in recent weeks by risk assessment and reduction to 1 metre social distancing.
- Day care management and staff appreciate the support and patience of service users and carers as day care works to increase placements and move towards a full return of service.



Day centre places available on **28.03.22** are marked by the **GREEN** column and those available on **18.05.22** are marked by the **BLUE** column

This shows an increase as follows;

Recent changes within the SHSCT and Mental Health and Disability Directorate.

The Disability Day Care Workstream

Has now been operational for 12 months. The workstream set up as a partnership between Trust, service user advocate and carer representatives have played an important role in increasing capacity within day care and transport services. Other service improvements progressed by the workstream have included representation to the Chair of the NI Assembly Health Committee on the critical need for rebuild of Oakridge Day Centre, Dungannon , the development of a quarterly newsletter for service users and carers, plus lobbying for more resources to expand day care accommodation across all localities within the SH&SCT.

Update on Day care accommodation.

- Disability Services have recently leased a former private day care facility in Newry for an initial 12 months. It should be operational in June 22, this will accommodate service users who previously received day care from an independent provider, and will also assist with additional places for the day care rebuild plan.
- In addition, a bungalow situated adjacent to Windsor day centre in Newry is currently being renovated and will provide further day care accommodation for day care attenders. This is a very welcome development for the expansion and development of day care services.
- Disability day care services have also submitted requests for the provision of portacabin accommodation in the Armagh/Dungannon and Craigavon / Banbridge localities as part of an overall expansion & rebuild plan with the aim of increasing day care placements.
