While patients with disabilities may be impacted due to potential difficulties with the preparation and administration of IV antibiotics carers will be able to help to allow them to avail of this service.


This policy is inclusive for engagement from all staff, patients and service users / family / carers, and provision of clinical audit can be made to meet Additional needs and to encourage participation as required:





The OUTPATIENT PARENTERAL ANTIMICROBIAL THERAPY team will ensure this policy and documents are adhered to when delivering SOUTPATIENT PARENTERAL ANTIMICROBIAL THERAPY across SOUTHERN HEALTH AND SOCIAL CARE TRUST and maintain appropriate records.

SOUTPATIENT PARENTERAL ANTIMICROBIAL THERAPY will be reviewed against British Society for Antimicrobial Therapy (BSAC) national standards for recording outcomes and in compliance with GPR.

The OUTPATIENT PARENTERAL ANTIMICROBIAL THERAPY team will engage regional OUTPATIENT PARENTERAL ANTIMICROBIAL THERAPY meetings to ensure peer review and quality assurance. All incidents will be reported via the trust datix system and discussed at the clinical teams M&M. The OUTPATIENT PARENTERAL ANTIMICROBIAL THERAPY team will undertake regular service review. Incidents / Adverse Incidents, complaints, service user feedback, and audits will be shared with stakeholders as necessary.
